10	General shall brief the appropriate committees of
11	Congress on the study required by subsection (a), to
12	gether with recommendations for such legislation
13	and administrative action as the Comptroller Gen-
14	eral determines appropriate.
15	(2) Report.—Not later than 6 months after
16	the briefing required by paragraph (1) is provided
