3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Ensuring Health Safe-
5	ty in the Skies Act of 2020".
6	SEC. 2. DEFINITIONS.
7	In this Act:
8	(1) Advisory committee.—The term "Advi-
9	sory Committee" means the Joint Federal Advisory
10	Committee established under section 4.

1	(2) AIR TRAVEL.—The term "air travel" in-
2	cludes international air travel.
3	(3) COVID-19 Public Health Emergency.—
4	The term "COVID-19 public health emergency"
5	means the public health emergency first declared on
6	January 31, 2020, by the Secretary of Health and
7	Human Services under section 319 of the Public
8	Health Service Act (42 U.S.C. 247d) with respect to
9	COVID-19 and includes any renewal of such dec-
10	laration pursuant to such section 319.
11	(4) Joint Task force.—The term "Joint
12	Task Force" means the Joint Task Force on Air
13	Travel During and After the COVID-19 Public
14	Health Emergency established under section 3(a).
15	SEC. 3. JOINT TASK FORCE ON AIR TRAVEL DURING AND
16	AFTER THE COVID-19 PUBLIC HEALTH EMER-
17	GENCY.
18	(a) In General.—Not later than 30 days after the
19	date of enactment of this Act, the Secretary of Transpor-
20	tation, the Secretary of Homeland Security, and the Sec-
21	retary of Health and Human Services shall establish the
22	Joint Task Force on Air Travel During and After the
23	COVID-19 Public Health Emergency.
24	(b) Duties.—

1	(1) In General.—The Joint Task Force shall
2	develop recommended requirements, plans, and
3	guidelines to address the health, safety, security, and
4	logistical issues relating to—
5	(A) the continuation of air travel during
6	the COVID-19 public health emergency; and
7	(B) the resumption of full operations at
8	airports and increased passenger air travel after
9	the COVID-19 public health emergency.
10	(2) Recommendations.—The recommenda-
11	tions developed under paragraph (1), with respect to
12	the applicable periods described in paragraph (3),
13	shall include—
14	(A) modifying airport, air carrier, security
15	(including passenger security screening), and
16	other operations related to passenger air travel,
17	including passenger queuing, boarding,
18	deplaning, and baggage handling procedures, as
19	a result of—
20	(i) current and anticipated changes to
21	passenger air travel during and after the
22	COVID-19 public health emergency; and
23	(ii) anticipated changes to passenger
24	air travel resulting from any seasonal re-
25	currence of the coronavirus;

1	(B) mitigating the public health and eco-
2	nomic impacts of the COVID-19 public health
3	emergency and any seasonal recurrence of the
4	coronavirus on airports and passenger air trave
5	(including through the use of personal protec-
6	tive equipment, the implementation of strategies
7	to promote overall passenger and employee safe-
8	ty, and the accommodation of social distancing
9	as feasible and necessary);
10	(C) addressing privacy and civil liberty
11	issues that may arise from passenger health
12	screenings, contact-tracing, or other processes
13	used to monitor the health of individuals en-
14	gaged in air travel; and
15	(D) operating procedures to manage future
16	public health crises that can be anticipated, to
17	the extent such public health crises may impact
18	air travel.
19	(3) APPLICABLE PERIODS.—For purposes of
20	paragraph (2), the applicable periods described in
21	this paragraph are the following periods:
22	(A) The period beginning on the date of
23	the first meeting of the Joint Task Force and
24	ending on the last day of the COVID-19 public
25	health emergency.

1	(B) The 1-year period beginning on the
2	day after the end of the period described in
3	subparagraph (A).
4	(c) ACTIVITIES OF THE JOINT TASK FORCE.—
5	(1) In General.—In developing the rec-
6	ommended requirements, plans, and guidelines
7	under subsection (b), and prior to including such
8	recommendations in the final report required under
9	section 5(b), the Joint Task Force shall—
10	(A) conduct cost-benefit evaluations re-
11	garding such recommendations, including costs
12	impacting air operations and impacts on air
13	travel;
14	(B) consider funding constraints;
15	(C) use risk-based decision-making; and
16	(D) consult with the Advisory Committee
17	established in section 4(a) and consider any
18	consensus policy recommendations of the Advi-
19	sory Committee submitted under section 4(b).
20	(2) International consultation.—The
21	Joint Task Force shall consult, as practicable, with
22	relevant international entities and operators, includ-
23	ing the International Civil Aviation Organization, to
24	harmonize (to the extent possible) recommended re-
25	quirements, plans, and guidelines for air travel dur-

ing and after the COVID-19 public health emer-
gency.
(d) Membership.—
(1) Chair.—The Secretary of Transportation
(or the Secretary's designee) shall serve as Chair of
the Joint Task Force.
(2) VICE-CHAIR.—The Secretary of Health and
Human Services (or the Secretary's designee) shall
serve as Vice-Chair of the Joint Task Force.
(3) Other members.—In addition to the
Chair and Vice-Chair, the members of the Joint
Task Force shall include representatives of the fol-
lowing:
(A) The Department of Transportation.
(B) The Department of Homeland Secu-
rity.
(C) The Department of Health and
Human Services.
(D) The Federal Aviation Administration.
(E) The Transportation Security Adminis-
tration.
(F) U.S. Customs and Border Protection.
(G) The Centers for Disease Control and
Prevention.

1	(H) The Occupational Safety and Health
2	Administration.
3	(I) The National Institute for Occupational
4	Safety and Health.
5	(J) The Pipeline and Hazardous Materials
6	Safety Administration.
7	(K) The Department of State.
8	(L) The Environmental Protection Agency.
9	SEC. 4. JOINT FEDERAL ADVISORY COMMITTEE.
10	(a) Establishment.—Not later than 15 days after
11	the date on which the Joint Task Force is established
12	under section 3(a), the Secretary of Transportation, in
13	consultation with the Secretary of Homeland Security and
14	the Secretary of Health and Human Services, shall estab-
15	lish a Joint Federal Advisory Committee to advise the
16	Joint Task Force.
17	(b) Duties of the Advisory Committee.—The
18	Advisory Committee shall develop and submit consensus
19	policy recommendations to the Joint Task Force for the
20	Joint Task Force to consider when developing rec-
21	ommendations under section 3(b).
22	(c) Membership.—The members of the Advisory
23	Committee shall include representatives of the following:

1	(1) Airport operators designated by the Sec-
2	retary of Transportation in consultation with the
3	Secretary of Homeland Security.
4	(2) Air carriers designated by the Secretary of
5	Transportation.
6	(3) Aircraft and aviation manufacturers des-
7	ignated by the Secretary of Transportation.
8	(4) Labor organizations representing—
9	(A) aviation industry workers (including
10	pilots, flight attendants, engineers, mainte-
11	nance, mechanics, air traffic controllers, and
12	safety inspectors) designated by the Secretary
13	of Transportation; and
14	(B) security screening personnel des-
15	ignated by the Secretary of Homeland Security.
16	(5) Public health experts designated by the Sec-
17	retary of Health and Human Services.
18	(6) Organizations representing airline pas-
19	sengers designated by the Secretary of Transpor-
20	tation.
21	(7) Privacy and civil liberty organizations des-
22	ignated by the Secretary of Homeland Security.
23	(8) Manufacturers and integrators of passenger
24	screening and identity verification technologies des-
25	ignated by the Secretary of Homeland Security.

1	(9) Trade associations representing air carriers	
2	(including major passenger air carriers, low-cost	
3	passenger air carriers, regional passenger air car-	
4	riers, cargo air carriers, and foreign passenger air	
5	carriers) designated by the Secretary of Transpor-	
6	tation in consultation with the Secretary of Home-	
7	land Security.	
8	(10) Trade associations representing airport op-	
9	erators (including large hub, medium hub, small	
10	hub, nonhub primary, and nonprimary commercial	
11	service airports) designated by the Secretary of	
12	Transportation in consultation with the Secretary of	
13	Homeland Security.	
14	(d) Vacancies.—Any vacancy in the membership of	
15	the Advisory Committee shall not affect its responsibilities	
16	but shall be filled in the same manner as the original ap-	
17	pointment and in accordance with the Federal Advisory	
18	Committee Act (5 U.S.C. App).	
19	(e) Prohibition on Compensation.—The members	
20	of the Advisory Committee shall not receive any compensa-	
21	tion from the Federal Government by reason of their serv-	
22	ice on the Advisory Committee.	
23	(f) Publication.—Not later than 14 days after the	
24	date on which the Advisory Committee submits policy rec-	
25	ommendations to the Joint Task Force pursuant to sub-	

1	section (b), the Secretary of Transportation shall publish
2	such policy recommendations on a publicly accessible
3	website.
4	SEC. 5. BRIEFINGS AND REPORTS.
5	(a) Preliminary Briefings.—As soon as prac-
6	ticable, but not later than 6 months after the date on
7	which the Joint Task Force is established under section
8	3(a), the Joint Task Force shall begin providing prelimi-
9	nary briefings to Congress on the status of the develop-
10	ment of the recommended requirements, plan, and guide-
11	lines under section 3(b). The preliminary briefings shall
12	include interim versions, if any, of the recommendations
13	of the Joint Task Force.
14	(b) Final Report.—
15	(1) Deadline.—As soon as practicable, but
16	not later than 18 months after the date of enact-
17	ment of this Act, the Joint Task Force shall submit
18	a final report to Congress.
19	(2) Content.—The final report shall include
20	the following:
21	(A) All of the recommended requirements,
22	plans, and guidelines developed by the Joint
23	Task Force under section 3(b), and a descrip-
24	tion of any action taken by the Federal Govern-
25	ment as a result of such recommendations.

1	(B) Consensus policy recommendations
2	submitted by the Advisory Committee under
3	section 4(b), and an explanation (including data
4	and risk analysis) of any action by the Joint
5	Task Force in response to such recommenda-
6	tions.

7 SEC. 6. TERMINATION.

The Joint Task Force and the Advisory Committee 9 shall terminate 30 days after the date on which the Joint 10 Task Force submits the final report required under sec-11 tion 5(b).
