City of Brockton	The Brockton Emergency Operations Center (EOC) is a component of the City's new Public Safety Complex, which is slated to be complete in August 2025. The EOC addresses multiple areas of need in Brockton by combining the operations of the Police, Fire, IT, and Emergency Management departments.	Brockton MA	\$2,500
Town of Hingham	Hingham's Public Safety Facility will be home to the Hingham Police Department Headquarters and the North Hingham Fire Station. The PSF will house the Emergency Operations Center.	Hingham MA	\$226
Town of Hull	This project will protect critical sewer infrastructure, an elementary school and more than 12 homes while enhancing public access on a popular walking route along the shoreline.	Hull MA	\$8,550
